How to Request Permission to Publish and Distribute Overeaters Anonymous Literature

- STEP 1:** On the first page of the License 2 agreement (and page 2 of the application), fill in:
- The current date and the name of the “Licensee”—the **service body (region, specific-focus/national/language service body, intergroup) or group**—entering into this License Agreement.
 - The title of the OA publication the Licensee seeks to license for publication and distribution and the language of translation.
 - The date License 1 was granted for this literature.
- STEP 2:** On pages 2–4, fill in:
- #3 with the proposed number, price, and type of copies of translated literature you intend to distribute. Fill in how you intend to distribute the translated literature, e.g., during OA meetings, group's/service body's online literature page, online platform, other.
 - The copyright information required in #5.
- STEP 3:** On pages 5–6:
- Sign and print your first and last name (electronic/typed signatures are acceptable), date your signature, and add your contact information.
 - Provide your service role in your registered group/service body.
 - Provide the name and registration number of the group/service body on whose behalf you are applying (registration numbers can be found at <http://oa.org/find-a-meeting>).
 - Fill your group's/service body's contact information: phone, website, email, and mailing address.
- STEP 4:** Complete the **Request for Permission to Use the Overeaters Anonymous Trademark (“Logo”) on an OA Publication** (pages 7–11). Submit example of Licensee's customized trademark, also referred to herein as a “logo” (page 11).
- STEP 5:** Send this completed License Agreement to the OA World Service Office by email to info@oa.org or mail to PO Box 44727, Rio Rancho, NM 87174-4727 USA.

A license will not be granted unless a copy of this Agreement is signed by an authorized agent of Overeaters Anonymous, Inc. (OA).

For good and valuable consideration, the Parties hereby agree:

2. OA Publication. Licensee seeks permission from Licensor to publish and distribute an OA

Licensee will make all changes to OA publication as requested by Licensor during the term of this
Agreement.

3. License. Licensor hereby grants to Licensee for the Term, the non-exclusive right to publish and
distribute the translated, validated OA publication in either or both of the following formats: (a)
physical ink-on-paper copies in bound book or pamphlet form; and (b) downloadable PDF files.

The total number of copies distributed in all formats combined shall not exceed _____ copies
during the Term. For purposes of this Agreement, each printed copy distributed and each PDF file
distributed shall count as one copy toward the _____-copy limit. Each transmission,
download, or distribution of a PDF file to an individual recipient shall constitute one copy for

purposes of the _____-copy limit.

Downloadable PDF distribution is limited to controlled delivery in response to a specific order or request from an individual purchaser or recipient. Licensee may provide the purchaser or recipient with access to download the PDF by email link, secure download link, or other controlled delivery method. Licensee may not post, upload, display, or otherwise make the PDF available for free, open, public, or unrestricted download on Licensee's website, online store, cloud storage account, social media page, digital platform, file-sharing service, or any other publicly accessible location. Licensee may not make the PDF available through open access, general browsing, public download links, or any system that allows persons to obtain the PDF without placing an order or making a specific request through Licensee.

Except for the downloadable PDF files expressly authorized above, no digital or electronic distribution rights are granted under this Agreement, including but not limited to print-on-demand distribution, e-books, websites, social media, mobile applications, online reading platforms, or any other electronic format or platform.

Upon expiration or termination of this Agreement, Licensee shall immediately cease all PDF distribution and remove all PDF files from any websites, platforms, and distribution channels under its control.

4. Term. The term of this Agreement begins on the date of the last signature (Effective Date) and shall remain in effect until December 31, 2027 (End Date), unless superseded by a revised licensing agreement executed by Licensor.

5. Markings. Licensee agrees that any OA publication published and distributed will be marked with the following:

6. Copies. Licensee will provide to Licensors one (1) electronic copy of the published translated OA publication. Electronic copy can be in text [Word] or PDF format.
7. Royalty. For the rights granted by Licensors, Licensee agrees to pay to Licensors a royalty calculated as follows: 10% of Net Income from the sale of licensed OA publication. Royalties shall be due and payable thirty (30) days after the first and each successive anniversary of the Effective Date of this Agreement. Net Income is defined as the excess of the selling price of goods over their direct cost. The remaining Net Income the Licensee derives directly or indirectly from sale, distribution, or other disposition of the Final Translation will be used exclusively for the not-for-profit purposes for which the Licensee was organized.
8. Reporting. Licensee will provide to Licensors upon Licensors’ request a written statement of the Royalties due to Licensors with respect to the OA publication sold.
9. Trademark. Licensee agrees to mark all Licensed OA publications with the OA logo. Licensors grants to Licensee the right to use a customized OA trademark as shown in the examples on pages 8 and 11 on all Licensed OA publications. All translations of OA literature must be marked with an approved OA logo customized with the service body’s registered name or group’s registered number. Licensee agrees to complete the **Request for Permission to Use the Overeaters Anonymous Trademark (“Logo”) on an OA Publication** on pages 7–11 and to:
 - a. insert Licensee’s name on the line immediately below the mark as shown on the form;
 - b. not make any alteration of the mark; and
 - c. use the mark only in accordance with guidance and directions, with respect to quality and marking, furnished to Licensee.
10. Termination. Licensors may terminate this Agreement at any time upon thirty (30) days’ written notice without cause, or immediately upon breach by Licensee of any clause of this Agreement. This Agreement shall automatically terminate upon the dissolution, liquidation, or legal cessation of

operations of Licensee. Upon termination under this section 10, Licensee shall immediately cease printing and distribution of the OA publication and turn over all copies of the OA publication to Licensors.

11. Sale of Existing Inventory After Expiration. Upon expiration of this Agreement, Licensee may continue to sell only those printed copies of the Licensed Publication that were lawfully printed and are in Licensee's possession on the expiration date. Licensee shall not print, reproduce, publish, convert, distribute in other format, or otherwise produce additional copies after expiration of this Agreement.
12. New License Required. Any continued sale or distribution of the Licensed Publication after Licensee's existing inventory has been exhausted shall require a new written license agreement executed by Licensors.
13. No Sublicensing or Transfer. The rights granted under this Agreement are limited solely to Licensee. Licensee may not sublicense, assign, transfer, delegate, authorize, or otherwise grant any rights under this Agreement to any other individual, group, service body, or entity without prior written consent of OVEREATERS ANONYMOUS, INC.
14. Law. The Parties to this Agreement understand that this Agreement will be governed and construed under the laws of the State of New Mexico and the United States of America, and the Parties consent to the jurisdiction of the State and Federal Court located in the State of New Mexico USA, and waive any defense to any such jurisdiction.
15. Signatures. This Agreement may be initiated by the Licensee signing and providing a signed copy to the Word Service Office by email or mail. The Agreement shall be signed by an authorized representative of the Licensee. The Licensee's and Corporate Secretary's signatures (original or electronic) are binding. Agreement is executed as of the date of signing by Overeaters Anonymous, Inc.
